## **SECTION 4 - FIRST AID MEASURES**

Material will accumulate static charges which may cause an electrical spark (ignition source), bond and ground containers when transferring material. Use spark-proof tools and explosion-proof equipment. Do not reuse containers without proper cleaning or reconditioning.
